

**OAKINGTON & WESTWICK PARISH COUNCIL**  
**OAKINGTON CEMETERY FEES 2026-27**

N.B. All of the fees detailed below shall be quadrupled for persons who are not at the time residents of Oakington or Westwick, save for those whom in the judgment of the Parish Council have strong links with the parish. e.g. by having lived here for much of their lives.

No fees are charged for children under the age of 18 years.

**INTERMENT IN EARTHEN GRAVES.**

N.B. all of these fees are payable at the time of each and every burial, regardless of whether or not the grave space was purchased in advance.

Interment of a person whose age at time of death exceeds 18 years.	£200.00
Interment of ashes.	£110.00
Scattering of ashes.	£110.00

**PURCHASE OF PLOTS.**

Reservation of space for a single earthen grave, before or at time of death	£250.00
Reservation of space for a double depth earthen grave, before or at time of death	£300.00
Reservation of space for ashes, before or at time of death	£120.00

**MONUMENTS.**

N.B. Prior written authority from the Parish Council is required before any form of monument is placed in Oakington Cemetery. All memorial masons used must be either BRAMM or NAMM registered. To obtain the necessary authority details of the proposed materials, style and inscription, together with the proposed locations shall be submitted in writing to the Clerk of the Parish Council. The Parish Council reserves the right to refuse any design or inscription that it judges will cause undue interference with the general maintenance of the Cemetery, or could be viewed as being offensive. In all cases, the decision of the Parish Council shall be final and binding and the Council reserves the right to refuse to explain or justify its decision in respect of any individual case.

For the right to place a stone no larger than 450mm square and level with the natural ground surface, or a headstone not exceeding 1 metre high.	£140.00
For the right to add or alter an inscription on an existing monument.	£90.00

N.B. 1. Monuments that do not fit into the above categories are not permitted.

N.B. 2. The granting of permission to erect a monument in the Oakington Cemetery is conditional upon the Parish Council not being held responsible for any damage to that monument, regardless of cause. Equally, in the case that a monument becomes dangerous the Parish Council may require that it be put to right, or removed at no cost to the Parish Council, which reserves the right to do so themselves after failing to get those responsible to do so.
