# Zero Carbon Communities Grant

SCDC's popular Zero Carbon Communities Grant will be open for applications from Monday 5<sup>th</sup> May and will close on Tuesday 1st July 2025. Parish councils and voluntary/community organisations are invited to apply for grants of between £2,000 and £15,000 for projects that reduce carbon emissions (e.g. from a community building) or foster greater community engagement on climate issues and encourage sustainable behaviour change. An online workshop is to be held on Wednesday 21<sup>st</sup> May 2025, 5pm - 6:30pm. Email zcc@scambs.gov.uk for more information or to sign up for the workshop.

### **Allotment Improvement Grant**

This grant funding can provide up to £10,000 to support projects that enhance the productivity, sustainability, and social value of allotment spaces. The key principles are introducing or improving water access, pest control measures (such as rabbit fencing) and introducing or upgrading facilities, such as toilets, to make the allotment environment more inclusive and suitable for a wider range of people. Applications for this grant will open on Monday 5 May and close in late August 2025 and parish councils and allotment societies are invited to apply. ### **Community Growing Grant**

Funding is also still available from the Community Growing Grant, which has been extended until the funding has all been allocated. This funding can help set up small projects such as raised beds, gardening equipment, soil, and seeds. For more information and to apply, visit the SCDC website.

## **County Council**

Responsibilities: Education, Transport, Highways, Heritage, Social care, Libraries, Trading standards, -Waste management, Maintaining their estate.

Some of these services are shared between Peterborough City Council and Cambridgeshire County Council but any concerns should be directed to the county council.

### **District Council**

Responsibilities: Council tax payments and benefits, Household bin collections, Housing and housing benefits, Council leisure facilities, Environmental health, Residential planning.

### Parish/ Town Council

Responsibilities: Looking after community buildings, Open spaces, Allotments, Play Areas, Bus shelters.

### Greater Cambridge Partnership (GCP)

'The local delivery body for a City Deal with central Government worth up to £500 million over 15 years, to vital improvements in infrastructure (decarbonising transport), supporting and accelerating the creation of 44,000 new jobs, 33,500 new homes and 420 additional apprenticeships.'

Partnership between Cambridge City Council, Cambridgeshire County Council, South Cambridgeshire District Council, University of Cambridge.

### The Combined Authority, Cambridge and Peterborough, our elected Mayor

'A combined authority (CA) is a legal body set up using national legislation that enables a group of two or more councils to collaborate and take collective decisions across council boundaries.'

What our mayor does – Business support, skills, housing, transport, environment, international, digital connectivity, resilience, research, and strategy. New homes.

### Police and Crime Commissioner, Cambridge and Peterborough
